*Following our communication of 10th April, we wish to keep you updated on the current and upcoming renovations at **Hilton Bora Bora Nui Resort & Spa**. Having reviewed the planning and timelines of this huge and exciting project that will refresh and upgrade the property, we can now announce that the renovations will occur in different stages, one zone at a time across 2015-2016, allowing us to keep the resort open.*

Once the 300's zone will reopen early next year, we will start the gradual renovation of the villas in other parts of the resort to continuously have accommodation available to offer. We will therefore be able to upgrade the property to a higher standard and prestige whilst staying operational.

The remodeling of the public areas, planned towards the end of 2016, are the only ones which may require a temporary full closure of the property as it would impact our operations and thus the comfort of our Guests.
